Dear Member:

We look forward to your continued support and participation. As a reminder, our monthly, general membership meeting is the 1st Thursday of every month at the Carson City Elk's Lodge. The RSVP-only dinner begins at 6 pm followed by the meeting at 6:30 pm.

As your board, we have decided that an increase to membership dues is necessary. We must be pro-active in our actions to ensure a healthy financial organization in our future. Membership dues should be used to support administration costs of the organization. In past years, we have used the proceeds from our Wine Walk to subsidize these fees. The Board feels strongly that we should gradually increase our membership fees to help support administrative costs and reach our goal of total coverage.

If/when the wine walk event can no longer function, this organization must not fail. For the last five years, we have been putting money into investment funds and feel this money should be used for marketing our member businesses. Thus, having membership fees covering our administrative expenses, would help minimize a sharp rise in membership dues if we were to lose the Wine Walk as our major funding event.

We as a board have shown our ability to be fiscally responsible and continue to provide marketing opportunities for our members, such as:

- Participation in the area's best Wine Walk
- Meetings with other DBA members once a month for a complimentary dinner with Downtown updates and networking opportunities
- The potential to bring customers into your business by taking part in new and existing DBA events
- Updated new website design and features
- DBA advertising campaigns that currently include monthly print ads to over 70,000 local addresses alongside digital event ads and social posts (Future advertising may include newsletters, radio spots and TV.)

Enclosed is the new DBA membership contract. Please read, complete the form and return the white copy with your payment to the DBA.

The DBA has run a successful and problem-free Wine Walk for many years. With liability insurance becoming harder to find, this contract serves as a reminder to our members of their responsibilities to keep this event safe and successful.

Payment is due by January 31, 2020 to avoid interruption of membership. A \$20 late fee will be assessed after the due date.
